## General Terms and Conditions

### Prices:

All food prices are per person, beverage prices per unit (bottle, glass, etc.) incl. VAT and service. Unless otherwise agreed in writing, they are due and payable to Stieglkeller immediately without deductions.

### Reservations:

Reservations must be made in writing (fax or letter) together with a signature, corporate stamp and VAT ID number. Any modification of the banquet arrangements must be made in writing. Salzburg shall be the legal venue. No orders will be processed without a signature. *Client acknowledges our General Terms and Conditions by signing the order.*

Unless otherwise agreed in writing, Client will confirm the **final number of guests in writing at least 10 days prior to the event**. This number will be the guaranteed minimum number that will be charged in any case.

If the number of guests should increase, Gassner - Stieglkeller – if notified by the Client less than three days prior to the event – shall use its best efforts to try to accommodate the additional requirements. Any additional costs arising shall be for the Client's account.

### Range of goods:

Our extensive line of goods is subject to seasonal changes. If certain items are temporarily unavailable, we reserve the right to replace these items with items of a comparable value. The offered goods are recommendations only and can be modified by the Client at will.

### Account:

Ordered menus and buffets shall be billed according to the ordered amount. Unless otherwise agreed, beverages shall be billed according to the amount consumed.

### Down payment:

A down payment in the amount of 50% of the expected total shall be transferred to our account at least 21 days prior to the event for events of 50 people or more. We reserve the right to request a higher down payment for large-scale events. If the down payment has not been credited to our account at least 10 days prior to the event, we reserve the right to cancel the Event Agreement without entitling the partner to claim damages.

### Terms of payment:

As usual in our line of business, invoices shall be due and payable within 10 days after the billing date without deductions. Default interest at a rate of 7% p.a. shall be charged in case of default.

The Client shall not be entitled to withhold payment on grounds of incomplete performance or defects. The Client shall only be entitled to offset a bill against an uncontested or legally binding claim.

Payments shall be credited against the oldest claims. A new order shall only be accepted upon full payment of any outstanding claims.

**Cancellations:**

Please notify us in writing at least 60 days prior to the event if you are forced to cancel the event for unforeseen reasons. In this case no cancellation fee will be charged. A cancellation fee of 50% of the ordered services shall be charged for cancellations made up to 31 days prior to the event except for social programs, for which 100% will be charged. A cancellation fee of 80% shall be charged for cancellations up to 21 days prior to the event.

100% of the booked services shall be charged for cancellations made 7 or less days prior to the date of the event. ALL CANCELLATIONS MUST BE MADE IN WRITING!

**Liability:**

All property brought onto the premises, particularly decorations, must meet the requirements of the fire authorities. Their installation must be coordinated with the event supervisor or manager. The organizer shall be liable for any damage arising from installing or removing such items.

**Registration:**

You as the organizer are responsible for obtaining any official permits that may be required. Any music performances must be registered and the AKM royalty fee paid.

**Complaints:**

Complaints must be reported to the event supervisor immediately. If the Client breaches his duty to report a defect and thus prevents it from being rectified on time or by the end of the event, the Client shall not be entitled to claim indemnification for any damage established.

**Non-performance:**

Strikes, fire or serious circumstances preventing contract performance that are beyond Stieglkeller's control, particularly Acts of God, shall entitle Stieglkeller to cancel the contract without liability for damages.



## Payment Conditions:

For events of more than 50 guests a deposit payment of 50 % is requested 4 weeks prio the event. The according invoice will be sent in time.

**The final payment for private Events has to be set in cash or via credit card at the latest the day after the event.**

All prices are including VAT . Place of jurisdiction is Salzburg.
